2. CM Scheme benefits:

TNAIOTA has asked all the clinic owners to register their Clinic under the CM Health insurance Scheme to get notified by the government. Dr.Sathyan has discussed the difficulties raised in getting registration. Dr.Suresh Kamalakannan clearly explained the Cm Scheme Registration Purpose and View of government.

3. Auditors/ IT filling:

TNAIOTA has discussed the appointment of Auditor and Advocate and informed the members to get help, in case of need.

4. Trust/ Proprietorship/ partnership:

TNAIOTA has discussed the importance of forming a type of entrepreneur and particularly insisted the members have a legalized partnership deed in case of partnership firm and also discussed the trust registration, 12a, 80g registration.
