- Our EC member, Dr. Janarthanan, spoke about the importance of OT clinics registration in CM's Health Insurance Autism Scheme, Clinical Establishment Act etc.

- One of the NGO in Chidambaram surrounding attended the program and appreciated the TNAIOTA & felicitated the officials.
- Lunch (Free) was provided to all the participants. Post Lunch, GB started with a welcome address & speech about the growth, achievements & success of TNAIOTA in the previous tenure.
- Convener presented the summary of the activities carried out by our TNAIOTA officials from 16th Aug'2020 to 27th Feb'2021.

As well as forthcoming agendas were discussed and the resolutions were passed. Agendas;

1. To enrol as a Life Member in TNAIOTA, payment should be transferred to TNAIOTA account only through Online payment will be accepted.

2. In our state no other professional branches are encouraged (for example; City branch/Zonal branch/District branch) to avoid confusion, to get united & to strengthen our State association. TNAIOTA will be registered in the society registration act.

3. TNAIOTA Members have to approach our parent body (AIOTA) through proper channels. Necessary actions to be taken for indiscipline, unethical activities, false information, acquisitions against our professional development activities/branch/chapter/ of office bearers and also our parent body should not encourage or accept the individual activities against TNAIOTA without the knowledge of the officials.

4. To function effectively many committees were formed like Zonal Coordinator& District Coordinators Committee, Clinic welfare, Govt. Schemes & Benefits Committee, Promotion Committee, NRI committee, Women's Empowerment Committee, Legal Committee & Committee for Academic, Research & Students etc. TNAIOTA will issue certificates for the committee members. It will function gradually with supervision of officials.

5. New ID card & Membership certificate will be issued for all the members. To get Permanent ID card, AIOTA Membership is mandatory. Temporary ID cards will be issued for those who are not having AIOTA Membership. Student Membership will be encouraged. Clinic registration certificates will be issued for clinic owners registered under TNAIOTA.

6. TNAIOTA will support the clinic Owner's welfare through proper guidance & assisting in the process of registration in Chief Minister's Health insurance scheme, Clinical Establishment Act, MSME etc.

7. TNAIOTA officials will be in follow up with Govt.officials to create vacancy/recruit OTst in the School sectors/ Govt. Hospitals/Institutions in the various disciplines & to include other differently abled conditions in Chief Minister's Health insurance scheme.

Co-convener/Treasurer Dr.Shankar, presented the accounts details given by Ex.Treasurer Dr. Arun kumar & it was circulated to all the members directly by our Ex.Treasurer Dr. Arun kumar before the GB meeting. The present treasurer will present the account details from 16th Aug'2020 in the next GB meeting.





In the GB meeting 22 members were present & queries were discussed and sorted out. Our office bearers Dr. Saravanan & Dr. Siva Subramanian was not attended due to health issues. Our Guest speaker was Dr.Hemalatha Radhakrishanan Senior Occupational Therapist, Ministry of health, Kuwait - MCHP & our senior member. She explained in detail through video demonstration and case documentation. It helped in correlating theory, practical and clinical perspectives. The Webinar had around 200 registered participants.

Zonal co ordinator & District co ordinator meeting was conducted on 15th June 2021 to discuss about the TNAIOTA activities to establish and create awareness about the Occupational Therapy profession in Town / Taluk / Panchayat level and to carry out the TNAIOTA officials activities in the Zonal & District level.

Clinic Welfare meeting was conducted on 27th June 2021 to discuss various agendas like about Mom's Belief, CM scheme benefits, Auditing/ IT filing / Trust / Proprietorship/ Partnership / Clinical Registration / Employee Salary Package / Mal- Practice etc., for the standardization of clinical practice and welfare of the clinic owners.

School sectors, OT recruitment as per MRP annual planner & to include OT Profession as Eligibility criteria for District Differently Abled Welfare Officer post.

A Rehabilitation camp was organised on 24th of October at Salem by Call for Care in association with TNAIOTA


