MODEL CODE OF CONDUCT TO BE FOLLOWED BY ALL CONTESTANTS AND VOTERS DURING THE ELECTION PROCESS

Dear Members of TN AIOTA,

I am pleased to inform you that now we are about to enter the final stages of the election process of TN AIOTA ELECTIONS 2020. With the declaration of the final list of contestants it is now just a matter of few days before the Final Election Day. I would like to convey my best wishes to all the contestants.

In view of the above it is hereby announced that the CODE OF CONDUCT would be applicable w.e.f. 01:00 PM on 01/08/2020 up to the announcement of the results of TN AIOTA ELECTIONS 2020 on 16/08/2020.

CANDIDATES:

- There shall be complete restriction of use of any of the official platforms of TN AIOTA including TN AIOTA official Whatsapp groups, Facebook page of TNAIOTA and any other official platform of TN AIOTA for election campaigning or any election related issues by any of the candidates directly or through their representatives.
- 2. No use of AIOTA logo, TN AIOTA logo, letterhead, stamp or any other official symbol is allowed by any of the candidates during their campaign.
- 3. Use of any unfair means to influence the voters including any specific benefits being provided to any of the voters is strictly prohibited.
- 4. Candidates have already been provided with the contact details of all voters through which they can contact any of the voters for campaigning purposes.
- 5. All powers conferred to the current officials of TN AIOTA would automatically freeze with the announcement of this model code of conduct.
- 6. Any financial transactions in the TN AIOTA bank account by any of the office bearers is strictly prohibited till the existence of this code of conduct.
- 7. Personal remarks and allegations specifically intended to tarnish the reputation of any specific candidates should be avoided.
- 8. Campaigning in any form shall be allowed strictly **up to 06:00pm on 07/08/2020 on**ly. Any campaign related conduct after this period will be considered as a breach in Code of conduct and appropriate actions would be taken.

VOTERS:

- 1. All voters are free to support any of the candidates as per their free will and can campaign on behalf of the candidates.
- Any unnecessary allegations or attempts to malign the image of any of the candidates or cause disruption to the election process should be avoided. Such acts if found true by the election committee will be dealt with appropriate actions against the individual doing the same.



3. There shall be complete restriction of use of any of the official platforms of TN AIOTA including TN AIOTA official Whatsapp groups, Facebook page of TNAIOTA and any other official platform of TN AIOTA for election campaigning or any election related issues by any of the voters till the existence of model code of conduct.

BREACH OF GUIDELINES

- 1. Any form of breach of the above guidelines may be directly reported along with appropriate evidences to the OIC, TN AIOTA Elections by email only to:_ electioncommitteetnaiota@gmail.com.
- All such complains would be verified independently by the election committee
 members to check the authenticity, validity and applicability of such complaints.
 Decision taken by the Election Committee would be final and binding to all.
